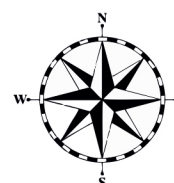

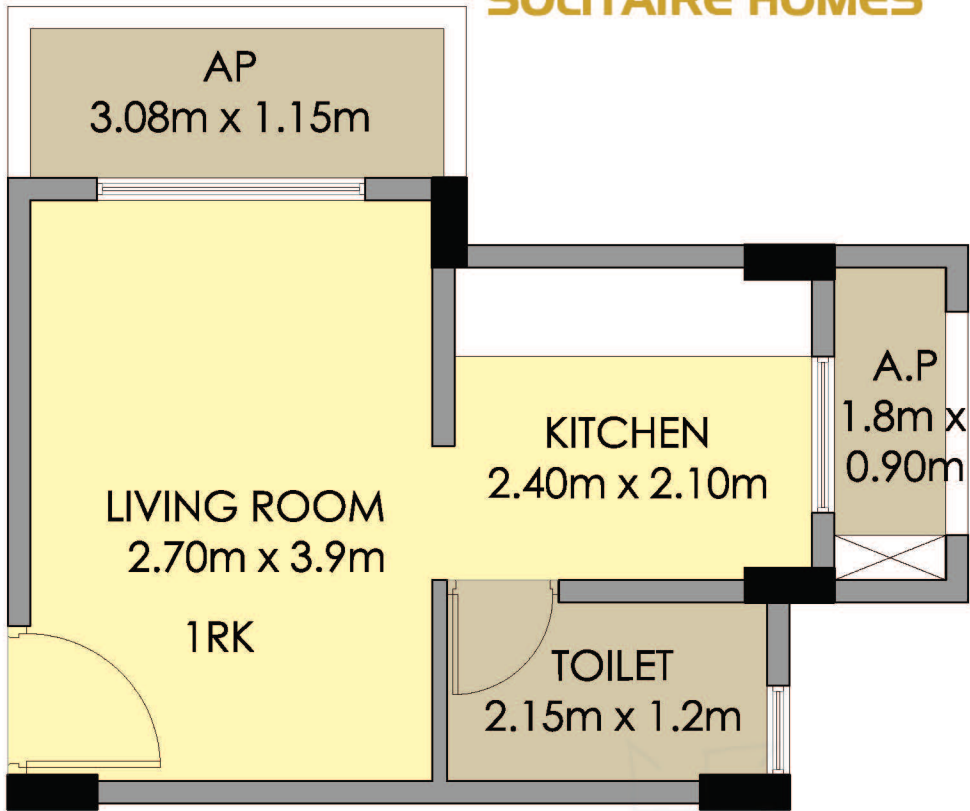


TYPICAL FLOOR PLAN BLDG NO. 1

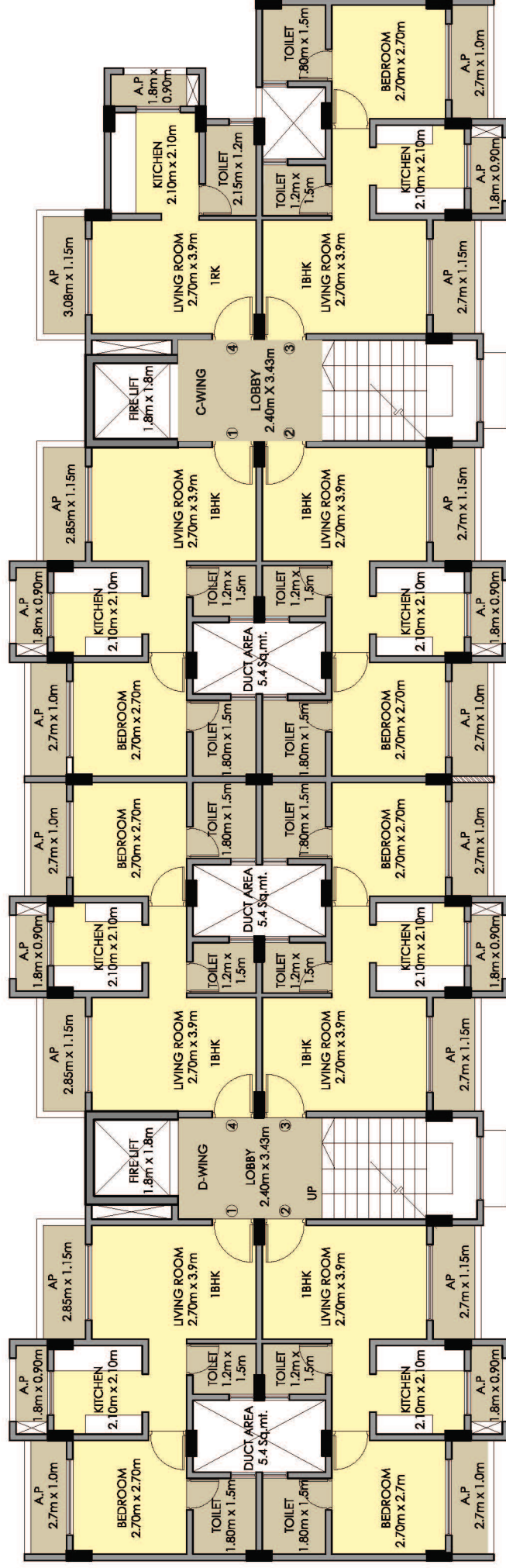

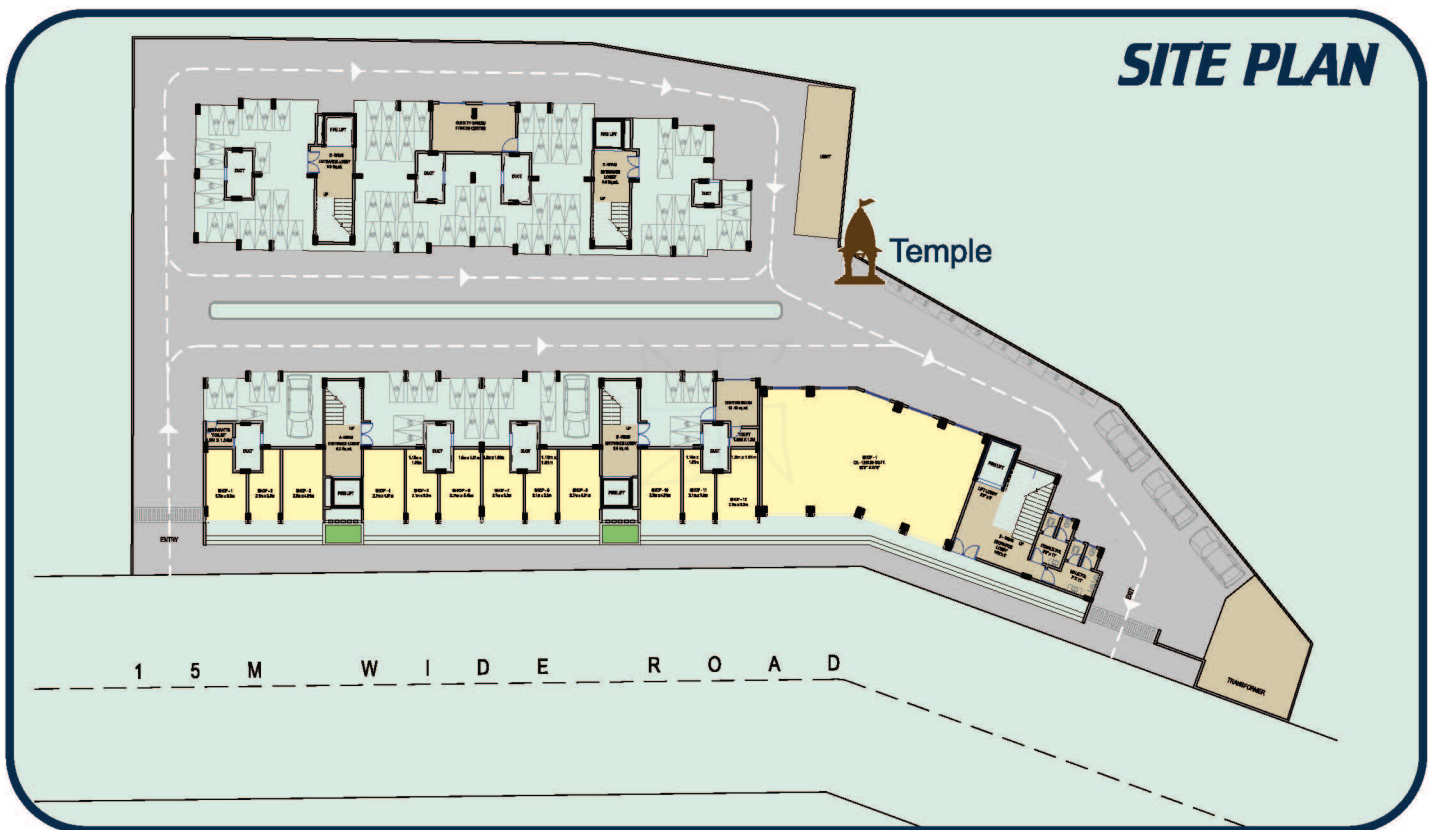
TYPICAL FLOOR PLAN BLDG NO. 2
